Kamkus college of law has organized a guest lecture by our LL.M. Alumni (2020-22) Sudhir Kochar on "The Law of Contract" for the students of LL.B. and B.A.LL.B. on 16th Nov 2022.



Mr. Sudhir Kochar began his lecture from the origin of the Contracts in India. And then he spoke about Contract law and various facets of Contracts in India. He spoke about the Aims and objective behind the Law of Contract, 1872.

Moving to the Bare Act next, he taught students the interpretations of the Act. He spoke about the importance of the Contract law in India. He quote many good authors to make student understand about the Law.

He also tell students that The Indian Contract Act was passed in the year 1872 and it came into force on the 1st day of September, 1872. The Act extends to the whole of India except the State of Jammu and Kashmir. It consists of 238 sections. It has been divided into 10 chapters. Chapter VII of the Contract Act is wholly repealed by the Indian Sale of Goods Act, 1930 (vide section 65). The Contract Act deals with particular contracts in separate chapters."

He then spoke about the aspect of contract law when two or more countries are involved, what law will prevails. He spoke in case of a contract in which two or more countries are involved in respect of its performance, questions arise as to the law of which country would govern such a contract. In the first instance, the law which would govern such a contract would be the law expressed by the parties themselves in the contract. In the absence of an expressed intention, the rule to apply is to infer an intention from the terms and nature of the contract and the general circumstances of the case.

Mr. Vijay Singh delivered a lecture on Consumer Protection Act and its implications for consumers for the students of LL.B and B.A.LL.B.

The lecture highlighted how consumers are treated as fools even today despite UN's 1989 guidelines on the same. The speaker moved forward in his session by inserting few excerpts on the consumer rights on products and how advertisement may sometimes mislead people. The speaker further highlighted the important concepts of Consumer protection moving on to the objectives of the Act. He further enumerated some of the landmark judgments in this area of law. He also talked about the importance of 'Unfair Trade Practice' in MRDP Act and Competition Act. Towards the end of the lecture, he advised students to be cautious not only as an individual but most importantly as a consumer.

The speaker concluded the session with a thought provoking explanation on how advertisement can mislead people, keeping in mind the latest Consumer Protection Bill 2018. In order to support his discourse, he gave example of Facebook and Zomato as platforms deliberately misleading people by collecting their personal data and later misusing the same for their own good.

A guest lecture on "Taxation system in India" was organized for the students of Kamkus College of Law, on 19th Nov 2023 Cs Prakash Pandey (Alumni 2020-22) was the resource person for the session.

Mr. Pandey explained the tax structure that constituted direct (income tax) and indirect taxes (Goods and service tax -GST). He elaborated upon the application and benefits of GST. He highlighted differences between the previous and new tax systems of India. Suggestions with reference to direct tax were also proposed by him. He stressed upon more use of direct tax as compared to indirect tax.

He compared the tax system of different countries and highlighted the various measures which other countries were adopting. He quoted the words of Albert Einstein "... complicated income tax is the hardest thing in the world to understand...." through which he explained the complexity of Indian income tax structure. It was a very interactive session which was supported by practical examples given by the resource person. Dr. Sanjeev Kumar Tyagi, Principal, Kamkus College of Law thanked Mr. Pandey for educating the students about the new changes in the taxation system of India.
