

Event Report November 18, 2023 BHARTIYA BHASHA ABHIYAN WORKSHOP







<u>Workshop on Use of Artificial Intelligence in Legal Teaching and Research</u> Jointly organized by Indian Law Institute, New Delhi and Kamkus College of <u>Law, Ghaziabad</u>

The Indian Law Institute (ILI), New Delhi and Kamkus College of Law (KCL), Ghaziabad jointly organized a one-day workshop on "Use of Artificial Intelligence in Legal Teaching and Research" on July 26, 2023 at the Indian Law Institute (ILI), New Delhi.

The workshop sought to acquaint law teachers and researchers from diverse institutions with the concept of AI and its application in legal academia. The primary objective was to explore and deliberate on the potential utilization of AI tools in legal teaching and research.

First session "Introduction to Artificial Intelligence and its Use in Academia" focused on the nuances of AI, its development, application, and challenges. It also discussed how AI can enhance general teaching and research experience in academia in various disciplines.

Second session "Use of Artificial Intelligence in Legal Research" focused on how AI can be used for legal research. It covered topics such as data sources, methods, tools, and platforms for legal data analysis; information retrieval systems for legal documents; argumentation and reasoning systems for legal problems; decision support systems for legal outcomes; and generative systems for legal content.

Last session "Use of Artificial Intelligence in Legal Teaching" focused on how AI can be used for legal teaching. It covered topics such as curriculum design and alignment with learning outcomes; content delivery methods like adaptive learning; assessment methods such as automated grading, feedback, and plagiarism detection; and learning analytics and personalization.


<u>One-Week Online Faculty Development Programme on Modern Teaching</u> <u>Techniques in Social Sciences</u>


