##### 2. Review and discussion of feedback taken in Academic year 2016-2017:

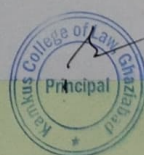

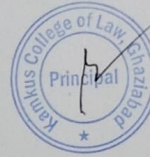

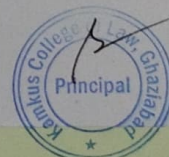

4. To discuss any other subject with the permission of the chair.





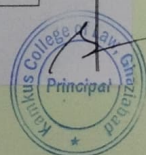
