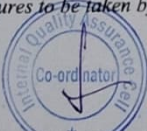
Agenda:

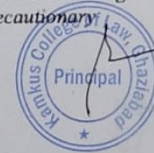

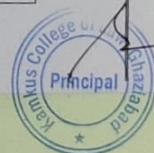

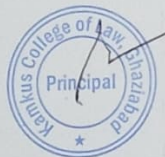
