WORKSHOP ON “MOOTING SKILLS”

(09th August, 2024)

The Moot Court orientation workshop was conducted by the Moot Court Committee at Kamkus College of Law (KCL), Ghaziabad, on **August 9, 2024**, in the Moot Court Hall at 11:30 AM. The session, led by Ms. Tabassum Baig, Assistant Professor and Committee Member, introduced freshers and final-year students to Mooting Skills, an essential subject in legal education.

Intra-Moot Court Competition

(30th August, 2024)

On **30th August 2024**, Kamkus College of Law hosted an Intra-Moot Court Competition for LL.B., B.A. LL.B., and B.Com. LL.B. students, with 63 participants competing in the Moot Court Room. The case involved ***State vs. John Doe***, focusing on possession and sale of allopathic medicines without proper licenses.

The Trial Court convicted the appellant, sentencing him to two years rigorous imprisonment and fines under **Sections 18(c), 27(b)(ii), 18A, and 28**. On appeal, the lower Appellate Court overturned the conviction under Section 18(c) due to insufficient evidence of sale or distribution, granting a refund of ₹1,00,000.

A criminal revision case was filed against the ruling but dismissed, as the Revisional Court found no legal errors in the lower court's judgment. The competition offered students a dynamic platform to enhance advocacy, legal reasoning, and procedural knowledge in a simulated courtroom.

Result: Team 11—Anushka, Gori, and Nibhejeet—emerged as the winners, while Team 9—Harshit Bhatti, Deepak Mishra, and Mitali—secured the runner-up position. Anushka was recognized as the best speaker.



The competition was presided over by the faculty members of the college.



Impact Analysis:

This activity provided students with practical courtroom experience, enhancing their confidence in legal proceedings, public speaking skills, and ability to interpret facts and apply laws effectively. It also improved their understanding of legal authorities, the relevance of responses, and the importance of maintaining proper posture during court proceedings, preparing them for real-world advocacy.

Intra-Moot Court Competition

(20th September, 2024)


On 20th September 2024, the Moot Court Committee of KCL organized a Moot Court Activity to provide students with a platform for enhancing their advocacy and research skills. A total of 27 students from B.A. LL.B., B.Com. LL.B., and LL.B. programs participated, each allotted 15 minutes to present their arguments.

The Moot Problem revolved around ***Amit vs. Ram Prasad***, dealing with issues of **rent enhancement, ejectment suits, and revision petitions under the Code of Civil Procedure, 1908**. The case explored contractual obligations, judicial discretion, and procedural challenges in rent disputes, making it a compelling legal exercise.

The primary issues debated were:

1. Maintainability of the Revision Petition under Section 115 CPC before the High Court of U.P.
2. Applicability of Order 2, Rule 2 CPC, determining whether a bar could be imposed on the respondent's suit.

Total 9 teams of 27 students consisting two participants i.e., Speaker 1, Speaker 2 and 1 Researcher from BA.LLB/B.Com.LLB. & LL.B. Ist, IIIrd, Vth, VIIth and IXth Semesters participated in the activity with great enthusiasm. The event was judged by faculty members. Programme concluded with vote of thanks proposed by Dr Seema Singh, Assistant Prof. KCL. This activity sharpened students' ability to analyze complex legal disputes, apply procedural laws effectively, and engage in courtroom argumentation. By replicating real litigation processes, the competition enhanced critical thinking, persuasive speaking, and legal interpretation skills, preparing students for future advocacy.

Intra-Mock Trial Competition

(10th October, 2024)

The Kamkus College of Law hosted a Mock Trial on 18th October, 2024, for five-year LL.B. students in the Moot Court Room. The trial focused on a contractual dispute between Singer Consultants Pvt. Ltd. and WinSoft Telecommunications Pvt. Ltd., involving lease termination and alleged contract breaches.

Case Summary: Singer Consultants leased Jubilee Plaza to WinSoft with a three-year lock-in period, ensuring maintenance in return for INR 2L monthly rent and a three-month security deposit. WinSoft unexpectedly terminated the lease in March Yr-2, vacating by June 30, Yr-2, despite lease restrictions. Later, they sent a legal notice alleging maintenance failures, though no prior complaints had been raised.

Trial Proceedings: The session examined lease termination legality, security deposit disputes, maintenance obligations, and delayed grievance claims. Students practiced legal research, argumentation, and case law application, enhancing their advocacy skills. During the mock trial, students conducted both examination-in-chief and cross-examination, in accordance with the Indian Evidence Act, further refining their litigation techniques and courtroom proficiency.

The Mock Trial successfully mirrored courtroom proceedings, offering practical exposure to contract law and litigation techniques.





Intra-Mock Trial Competition

(Witness Examination Under the Indian Evidence Act)

(08th November, 2024)

As part of the *Mock Trial* conducted on **8th November, 2024**, the students from 5-year LL.B. of Kamkus College of Law, engaged in a rigorous courtroom simulation, applying key provisions of the **Indian Evidence Act** to the criminal case ***State vs. Mukesh***. The proceedings emphasized the structured examination of witnesses, a fundamental aspect of trial advocacy:

As the prosecution team, we presented witnesses whose testimony substantiated the charges **under Section 325 IPC**, establishing facts related to grievous hurt. The defense rigorously cross-examined them, exposing inconsistencies and testing credibility to create reasonable doubt. To reinforce reliability, the prosecution addressed ambiguities raised during cross-examination. Additionally, a forensic expert, examined under **Section 45** of the **Indian Evidence Act**, provided a scientific analysis of the injuries, further strengthening the evidentiary framework.

This exercise was an invaluable opportunity for us to grasp the procedural intricacies of criminal litigation, refine our argumentation skills, and understand the impact of witness examination in shaping judicial outcomes.

Kamla Sukul Memorial Intra-Moot Court Competition-2025

The Kamla Sukul Memorial Intra-Moot Court Competition-2025, held on April 25 & 26, 2025, was a prestigious academic event that provided law students with a platform to enhance their advocacy and research skills.

A total of 17 teams participated, with faculty members and alumni present at the inauguration. After preliminary, quarter-final, and semi-final rounds, Team KSM-15 (Xth Semester, B.A.LL.B.) emerged as the winners in the final round.

The moot proposition focused on digital privacy vs. government surveillance, involving **Starfuel Co. Ltd.**'s legal battle over unauthorized data access and fraud allegations. Key legal issues discussed included Fourth Amendment protections, the Stored Communications Act (SCA), the Third-Party Doctrine, evidence suppression, and balancing privacy with government investigations.

The competition concluded with a ceremonial event, where Chief Guest **Prof. (Dr.) K.K. Mittal** and Guest of Honor **Prof. (Dr.) Anjali Mittal** expressed gratitude to participants, organizers, sponsors, and volunteers. 




National/International Moot Participation:
