Students also performed a short skit on the topic of "Cyber crimes and remedies against them" it was very informative and well executed performance by the students.

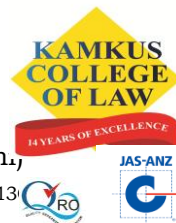

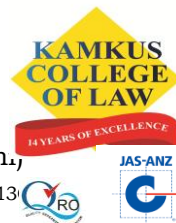

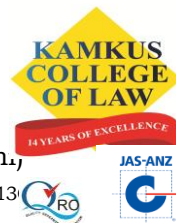
